Class and Division Specifications:

Hunter Classes: Open to ponies and horses. To be judged on performance, soundness, way of going and when indication, manners and suitability. Extreme speed will be penalized. Hunter classes will be run over a course of at least seven to eight fences with at least one change of direction. Clothing should be neat and conservative. The judge may penalize an entry for unconventional types of bits, nosebands and martingales. Martingales are NOT permitted in hunter under saddle classes. The use of boots and bandages are prohibited in hunter classes.

Walk-Trot Jr/Am Novice Classes: Cross entry restrictions. Walk-Trot Jr/Am classes are for novice riders only, that have not won a total of three first place ribbons. Walk-Trot Novice riders MAY NOT cross enter to any other class that canters; except the Opportunity X Rails or Mini Stirrup class(es). Riders may be asked to walk or trot through or over ground poles and demonstrate a halt in class #13.

Walk-Trot Open: Open to all riders and horses/ponies; no cross entry restrictions.

Equitation Classes: To be judged on the rider's hands, seat and control of their mount over fences and/or on the flat. Open to junior or adult amateur riders and horses or ponies. USEF Tests 1-9 may be asked in equitation classes.

Jumper Classes: Open to all riders on any pony or horse, unless otherwise noted. Spreads not to exceed fence height. To be scored, unless otherwise noted, Table II, Sec. 2 B. Per USEF Jumper rule: Table II, Sec. 2 (b)—The first round and first jump-off, if any, are decided by adding together the faults incurred over the course and any penalties for exceeding the Time Allowed. If a competitor has gone clean in the first round, the competitor will, without leaving the ring, upon an audible signal, commence the designated jump-off course. A competitor with a clear round may dismount, and with assistance if necessary, adjust tack and/or equipment; however, upon the audible signal to begin his/her round, the competitor is responsible to adhering to the 45 seconds rule as per JP134.3. A competitor who leaves the arena after a clear round (before or after the tone) will be considered to have retired from the jump-off. If there are no

clean rounds and a tie exists for first place, there will be one jump-off in which time will decide in the event of equality of faults. It is recommended that no more than ten numbered obstacles be included in the first round when the class is scored under this table. Class #1 and #2 to be scored under a one round format, Table IV Sec. 1. The round is decided by adding together the faults incurred over the course and any penalties for exceeding the Time Allowed. In the case of equality of faults, ties will be broken on the following basis: an "Optimum Time" (defined as 4 seconds less than the Time Allowed for the course) will be posted on the course plan; the horse with the time on course closest to this Optimum Time (over or under) will prevail in the tie, next closest next, etc.

Class #14 Ground Pole Hunter Open: To be a course consisting of 7-8 ground poles in a figure eight pattern. Poles may be trotted or cantered, open to all riders and horses/ponies. Trotting is not penalized.

Class #24 Camelot 2' Jr/Am Medal: Open to all junior and adult amateur riders. To be shown over an equitation type course of not less than eight fences at 2' in height, including at least two changes of direction. Work-off at judge's discretion. USEF Tests 1-9 may be asked in course or work off. Special prize and ribbon to 1st place.

Class #29 \$100 Camelot Hunter Derby: To be eligible, horses must have shown in at least two other classes at the same show. Open to all riders and horses. The class combines a hunter classic with a handy hunter class in a one round format. Minimum of eight fences set at 2'6" with a minimum of three option fences at 2'9". An additional point will be awarded for each option successfully jumped. The course will be built to encourage and reward brilliance and daring from the rider and true athletic ability from the horses. Prize money paid to top three places; 50%, 30%, 20%. Special ribbon to 1st place.

Class #7 \$100 Camelot Jumper Classic: To be eligible, horses must have shown in at least two other classes at the same show. Open to all riders and horses. Fences set at Level 2 1.00M (3'3") Table II, Sec. 2 B. Prize money paid to top three places; 50%, 30%, 20%. Special ribbon to 1st place.

RULES AND GENERAL INFORMATION:

MANAGEMENT—The Horse Show Management reserves the right to itself to interpret all questions and conditions in regard to or rising out of or incident to the Show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by the Horse Show Management, and their decision is to be final. The Horse Show Management reserves the right to change any course, cancel or combine any unfilled classes, reschedule classes after due notice to exhibitors, change rings or rotate judges.

PRIZE MONEY—Prize money from classes #7 and #27 can either be deducted from entry fees or paid by check from CEPF at conclusion of horse show. Please go to show office to receive prize money.

UNPAID CHARGES—Any exhibitor leaving the show with unpaid entry fees will be billed and a \$25 billing fee will be added to their charges. Please close out at the office at the end of show day prior to leaving grounds.

RETURNED CHECKS - Checks returned by the bank will be handled as follows: All returned checks will be charged an additional \$25 penalty.

SCHOOLING RULES - Schooling will be permitted in designated areas only. Violations of Schooling regulations may be considered cause for elimination. Show Arenas will be open for HACKING ONLY the day prior to the show starting at 8AM. Once the courses are set for show day, there is no more schooling allowed. ABSOLUTELY NO SCHOOLING ALLOWED IN SHOW ARENAS THE MORNINGS OF SHOW DAYS. No jumping or lunging allowed in dressage courts. Please lunge by Green Barn only. Do not use round pen by boarder area; that is for Camelot boarders only. Please check with CEPF for schooling on cross-country course.

SCRATCHES/ADDS - Classes must be scratched or added at the office before the class begins to receive a refund. Scratches/adds at office ONLY, please do not scratch/add at back gate.

STABLING—Stalls in the Green Barn and 12x24 pipe pens are first come first serve basis days of horse shows. To make stabling requests, please contact show manager. Bedding and hay may be available, please contact show manager for options and prices.

REFUNDS – Refunds for pre-entries will only be refunded if canceled before closing date of show (or 7 days prior to show date). Scratched entries must have doctor or veterinary note to receive full refund. Management has right to retain office and drug fees for scratched entries if they do not meet the above criteria. After the show starts, class refunds will be given provided class is scratched in the show office before class begins.

SCHEDULING - Although management will make every effort to work with exhibitors, rings will NOT be held open for extended periods of time due to conflicts. Reasonable time limits for classes will be enforced!

NON SHOWING HORSES - Any horse on the grounds that are not showing in the horse show will pay a \$20 non showing fee and must register at the show office.

ATTIRE – All persons when mounted anywhere on the competition grounds, must wear a properly fastened protective headgear which meets or exceeds ASTM/SEI standards for equestrian use. Riders should have a neat and clean appearance and must wear beige, tan or light colored breeches, boots (half chaps are acceptable en lieu of tall boots) and collared shirts.
